Please read and initial each policy:

_____ I understand that payment is due by the first class of each month, with a grace period until the second class of the month. After the second class of the month, the payment is late and I will be charged a \$10 late fee. Tuition is the same for shorter months and months with holidays. Longer months average the classes out.

_____ I will be on time picking my child up from class. I understand that other classes are starting right after my child's class.
